## SECTION 4: First aid measures

<b>Inhalation</b>	If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. For breathing difficulties, oxygen may be necessary. Call a physician if symptoms develop or persist.
<b>Skin contact:</b>	Take off immediately all contaminated clothing. Get medical attention if irritation develops and persists. Wash skin thoroughly with soap and water for several minutes.
<b>Eye contact</b>	Remove contact lenses, if present and easy to do. Get medical attention if irritation develops and persists. Promptly wash eyes with plenty of water while lifting the eye lids.
<b>Ingestion:</b>	Call a physician or poison control center immediately. If swallowed, rinse mouth with water (only if the person is conscious). Do not induce vomiting. If vomiting occurs, the head should be kept low so that stomach vomit doesn't enter the lungs.

## SECTION 5: Firefighting measures

<b>Suitable extinguishing media:</b>	Water spray, fog, CO <sub>2</sub> , dry chemical, or alcohol resistant foam.
<b>Unsuitable extinguishing media:</b>	Do not use a solid water stream as it may scatter and spread fire.
<b>Specific hazards arising from the chemical:</b>	Fire may produce irritating, corrosive and/or toxic gases.
<b>Special protective equipment and precautions for firefighters:</b>	Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Structural firefighters protective clothing will only provide limited protection. Wear self-contained breathing apparatus with a full facepiece operated in the positive pressure demand mode when fighting fires.

### Fire fighting equipment/instructions:

In case of fire and/or explosion do not breathe fumes. Use standard firefighting procedures and consider the hazards of other involved materials. Move containers from the fire area if you can do so without risk. Water runoff can cause environmental damage. Ventilate closed spaces before entering them. Keep run-off water out of sewers and water sources. Dike for water control.

**Specific methods:** Use water spray to cool unopened containers.

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures:

Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor. Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.

### Methods and materials for containment and cleaning up:

Collect and dispose of spillage as indicated in section 13 of the SDS.

Absorb with inert absorbents such as dry clay, sand or diatomaceous earth, commercial sorbents, or recover using pumps.

The product is immiscible with water and will spread on the water surface.

Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible.

Never return spills in original containers for re-use. This material and its container must be disposed of as hazardous waste. Eliminate all ignition sources (no smoking, flares, sparks or flames in the immediate area). Prevent products from entering drains.

**Large Spills:** Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with a plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers.

**Small Spills:** Wipe up with absorbent material (e.g. cloth, fleece). Clean the surface thoroughly to remove residual contamination.

**Environmental precautions:**

Retain and dispose of contaminated wash water. Avoid release to the environment. Contact local authorities in case of spillage to drain/aquatic environment. Prevent further leakage or spillage if safe to do so. Do not contaminate water.

**SECTION 7: Handling and storage**

**Precautions for safe handling:**

Do not handle or store near an open flame, heat or other sources of ignition. Take precautionary measures against static discharges. All equipment used when handling the product must be grounded. Avoid breathing vapor. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. Wash thoroughly after handling.

**Conditions for safe storage, including any incompatibilities:**

Keep the container closed. Handle containers with care. Open slowly in order to control possible pressure release. Store in a cool, well-ventilated area.
